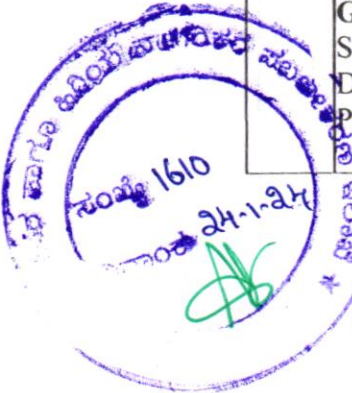
**NOTIFICATION**
